Growth will likely to be in the 3%–4% range, driven by strong consumer spending.

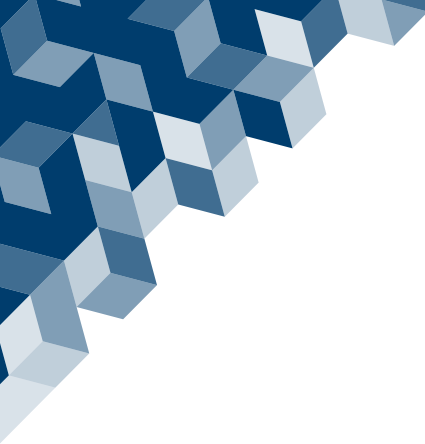
