Class C shares

You don't pay a front-end sales charge when you buy Class C shares, but you may pay a CDSC when you sell Class C shares.

Class C share maximum investment is \$999,999, with the exception of the Tax Exempt funds, for which the maximum investment is \$499,999.

Class C shares automatically convert to Class A shares of the same fund in the month of, or the month following, the 8-year anniversary of the Class C shares purchase date. Conversions will occur on the 15th of each month (if the 15th is not a business day, then the next business day thereafter). No sales charge or other charges apply in connection with this automatic conversion policy, and conversions are free from U.S. federal income tax. Any shares you received from reinvested Fund distributions will generally convert to Class A shares at the same time. New purchases placed on the day of the conversion event are not affected, as the only Class C shares eligible for conversion are those that are 8 years old. Shares received through a transfer or exchange placed on the day of the conversion event will convert if 8 years old; otherwise, they will remain in the C share account until they reach 8 years.

The CDSC on Class C shares:

- Is applied to the net asset value at the time of your purchase or sale, whichever is lower
- Will not be applied to any shares you receive through reinvested distributions or on any amount that represents appreciation in the value of your shares, income earned by your shares or capital gains
- Is reduced to 0.00% on shares redeemed a year or more after purchase
